Contractor construction estimates came in low, so it will include 20 or 30 Residential Rain Gardens in each proposal. There is a match of at least 25% required, but this could be in-kind labor by DCVA, Haverford Public Works, EAC Rain Gardens Team or other volunteers. Support letters are expected from the Township Manager, Parks and Recreation, Upper Darby, Philadelphia Water Dept. and the Eastern Delaware County Storm Water Collaborative (EDCSWC). EAC agreed to also submit support letters. P. Puglionesi indicated that SEPTA management reportedly sent a concurrence letter for the Hathaway Bioswales project, a third potential NFWF grant application, located on SEPTA property.

100 Rain Gardens Initiative: A planning meeting was held with the first of 5 owners to get spring 2015 rain gardens. The agreement was signed and several team members reviewed one-call markings reviewed, locations, size (approximately 10 ft. diameter and 6 in. deep) and plants with the homeowner. The tentative installation date is May 17th. P. Puglionesi noted this is the date of the Spring Music Festival, so some volunteers may have conflicts. Oakmont Rain Garden: D. Schwartz and J. Anderson of EDCSWC submitted a \$500 mini-grant in Jan. to NFWF for planting the Oakmont Rain Garden. Awards to be announced in March. Businesses interested in sponsoring rain gardens and supporting the program will send contributions earmarked for Hav-a-Rain Garden program to HTCC. P. Puglionesi and D. Schwartz will serve as liaisons to the HIB Task Force. NFWF Grants: No new developments. The two prior DCVA applications for National Fish and Wildlife Federation (NFWF) grants for Chatham Glen Park and Thompson Nature Park to construct treatment wetlands and added storage capacity and a third potential application for the Hathaway Bioswales project (with SEPTA approval) can be submitted for "preapproval" by Temple University staff advising NFWF and submitted in later rounds to NFWF. 100 Rain Gardens Initiative: Five gardens were selected and planted in September and early October culminating in the garden planted on Darby Road during Haverford Township Day. <u>DEP MS4 Permit for TMDL Watersheds</u>: D. LaBrake attended a DEP workshop for watershed groups and relayed that the revised MS4 General Permit is expected to be finalized in early 2016. It will include a requirement that every municipality discharging to an impaired water must put together a plan, with real projects identified and costed out, for reducing their contribution to the cause of impairment by 5%-10% over the 5-yr term of the permit.
